

Comments on the financial results:

- The assets of SIBMAS on 01.01.2018 amount to € 33102,5.
- The current situation is very healthy because of
 - The tax return for the 2016 CPH congress made an extra benefit, bringing us a positive result of € 17'997,31.
 - We are also closing the 2017 fiscal year with a net positive result of \in 1'538.16.

- 2018 budget:
 - Year of the organization of the biennial congress
 - We continue to control our expenses in relationship to our revenues
 - Registration fees are being cashed in and Nicole Leclercq's follow-up is remarkable (more provisions this year).
 - The variable costs are well balanced.
 - We are expecting an overall sponsorship amount of 9'266.59 euros, which will allow our accounts to be balanced at the end of the 2018 Paris Conference.

Jan reminds us that the negative figures of 2013-2015 were due to the investments in the website (total of \in 15'000) but have proven worthwhile.



Membership situation

With the possibility of a national membership APAC introduced in 2015, SIBMAS lost more than 60 members. For the 2014 NY Conference, membership was required. A large part of these new members didn't renew their SIBMAS membership.

After three years of not paying membership fees, members are deleted from the Members' Directory.

In 2018, the upcoming conference (you had to be a member to present a paper) and the improved communication (website and emails) have increased the membership again. Membership fees are the major source of income for SIBMAS, and enable the realisation of SIBMAS projects. Despite a lot of invoicing problems more members have already paid their fees for 2018 -- thanks to the hard work of Nicole.

SIBMAS members come mostly from Europe, but there is a positive evolution on other continents as well (especially Asia).


Proceedings CPH 2016



Two volumes of the proceedings were published (EN + FR). This involved more work than imagined, so maybe we should publish one bilingual volume (as was done previously). The translation took a lot of time as most of it was achieved without professional translators (=budget!). The results of the new graphic designer and printer were really satisfying. A handbook will be written in order to manage the next publication (eg. SIBMAS should require formatted papers; Britain and American English).

The costs were reduced because of the choice of

black/white printing, with a color front cover (which features a color picture of the group photo in CPH on the back cover). A professional translation of all papers would cost about € 30.000, unaffordable for SIBMAS. SIBMAS now offers proceedings to all members. Representatives of an institution will each receive a copy at the conference. Non-members will receive the London proceedings, as publicity to join SIBMAS.




Communication

Website:

The website users increased and they are more active on the website. The increase of the traffic is due to the coming conference and to new communication strategies. Facebook and the eNewsletter increase traffic on the website. The chronological comparison shows an increase of the website traffic every congress year. Paris' Conference still has to start, so normally we should have more visitors and page views than ever before at the end of 2018.

eNewsletter:


We ask members to contribute and we developed a shorter, brighter, illustrated format - an efficient strategy (622 subscribers, +11,25 %). In addition to the existing 4 categories (events, exhibitions, publications, collections), a 5th category has been added to present the Members appearing in the Members' Directory. Approximately 200 subscribers are potential members of SIBMAS. Open and Click Rates are both a lot higher than the industry average. The recent increase of these rates is due to a shorter and more illustrated Newsletter. Most of the top clicked links in the eNewsletter are links to the SIBMAS website. The traffic on the website increases with each eNewsletter.




Facebook:

289 Likes. Increase of the page "likes" due to weekly publications of members and non members and flashnews for the conference. Most of the top- reached posts are links to the website. Communication about the conference was at the same time published on Facebook and sent by a separate Newsflash.

These produced more significative traffic increase on the website, where catchy information about the SIBMAS Conference is currently displayed.





Leaflet

A new leaflet (FR/EN) has been developed with the kind support of the CNCS, which will be distributed to all congress participants in Paris. The idea is that SIBMAS Members can ask for copies and distribute them at other meetings or conferences.
